

The Session's Authority and Responsibility Concerning Public Corporate Worship

Over the next several months, I would like to explain in detail the biblical basis by which the Session determined to maintain public corporate worship at Newberry ARP Church. While the majority of churches, including most ARPs, suspended their corporate worship services for several months (and some have still not resumed), your Session prayerfully and thoughtfully considered our governing documents (the ARP Standards) and the Scriptures to determine how we would lead and shepherd this congregation. It is my prayer, as we still journey through this coronavirus pandemic that you all will gain a greater sense of trust and confidence in how the Lord has sustained and guided our congregation.

The question that the Session had to resolve was: What is the scope of a Session's authority regarding a congregation's public corporate worship? The answer to this question primarily relates to the statement found in our Form of Government (FOG) concerning the Authorities and Responsibilities of the Session:

6.8 In order to carry out its responsibility, working under the proper jurisdiction of the higher courts, the Session shall: L. Exercise, in accordance with the Directory of Public Worship, authority over the time and place of the preaching and teaching of the Word and the administration of the sacraments, and over all other religious services

Based on the Directory of Public Worship (DPW) "the preaching and teaching of the Word and the administration of the sacrament, and...all other religious services" clearly include the weekly Lord's Day corporate worship service. Therefore a Session has the authority in accordance with the DPW¹ to determine the **time** and **place** of a congregation's public corporate worship.²

The Responsibilities of a Session and the Congregation

A subtle but formal distinction that we need to recognized in resolving this question is the difference between the responsibility of the Session in **calling** its members for corporate worship and the response of the members in **gathering** for worship.³ Though the visible outcome may be the same for both parties, the question of authority is not. The Session in this instance calls and the members gather. Admittedly the elders have the same, if not more due to their office,⁴ obligation to gather for worship as the members but in this instance the Session is acting as a governing court of the congregation. By their action, the Session is exercising its authority to guard and promote the spiritual welfare of the congregation.⁵

In shepherding the flock of God, the Session is regulated primarily by Scripture and the Standards. The Session should as caring and wise under-shepherds take into consideration the members' response in guiding their

(3.6) It is to be understood in the narrow sense of particular occasions of worship that is public, formal, and planned. (DPW 3.3 and 3.4)

governance, but it should not be the only or even the primary factor. They must patiently and graciously uphold the truths of Scripture calling God's people to faithfulness and progressive spiritual maturity. Providential circumstances and individual consciences may prevent all members from responding uniformly, but that should not deter the Session in upholding biblical directives. The lack of ability or commitment of some members to fulfill or submit to the Session must not compromise the authority of Scripture. The Session must lead the congregation in its unswerving commitment to the precepts and principles of Scripture while doing all it can to encourage the congregation to joyful and heartfelt obedience to the Lord. Neither the degree nor the proportion of the congregation's compliance should persuade the Session in disregarding the commandments of Holy Scripture.

In seeking to determine the scope of a Session's authority in this sphere, several related topics need to be addressed and clarified. Even within section L, there are qualifications, "in accordance with the Directory of Public Worship" and "the time and place," that set certain limits to the Session's authority. Moreover, other portions of the ARP Standards provide vital insights that necessarily regulate this authority.

The Essential Nature of Corporate Worship for a Congregation

The locus of this discussion begins within the context of the local congregation. A congregation, a local visible expression of the ARP Church, is defined by the FOG as "a company of Christians, with their children, associated together according to the Scriptures for worship and ministry in the name of Christ." According to this definition, the two necessary and visible attributes of a congregation are **worship** and ministry. Therefore, worship is **essential** in defining what a congregation is; so much that a congregation that ceases to worship corporately is on the verge of desisting as a congregation. This fact is confirmed by the FOG 3.21 when it states, "When a congregation becomes so reduced in its membership and strength as to be unable to **maintain the ordinances of regular public worship...** in the judgment of Presbytery, best served by dissolving the congregation, Presbytery shall formally **declare it dissolved**." One of the stated reasons for a Presbytery to dissolve a congregation is its inability to maintain regular public worship. Public worship is so essential to the essence of a congregation that its existence is contingent on its regular gatherings.

The FOG continues to express the purpose of a congregation as being "to glorify God by conducting public corporate worship, bringing the lost to a saving knowledge of Jesus Christ, building them up in the Christian faith, and preparing them for Christian service." In summary, the chief end of a congregation is consistent with the chief end of man (WSC Q.1), namely, to glorify God (and to enjoy Him forever). One of the four means (listed with the preposition "by"), and the first, by which a congregation fulfills this purpose is "by conducting public corporate worship." This first means, along with the other three means, is how a

congregation seeks to glorify God. ¹² A congregation is not limited to these means alone (as long as they conform to the Bible and our Standards), but they are the primary and **necessary** means in fulfilling its purpose.

In considering the various means, or ministries as they may be called, of a congregation, what becomes evident is that the other three means can be fulfilled by conducting public corporate worship. In other words, if a congregation is only able to conduct public corporate worship but not the others three means separately, it is still possible to fulfill its purpose. On the other hand, even if the other three means are being conducted in some other form or ministry, but public corporate worship is not, then it can be argued based on the inclusive nature of the conjunction "and" that a congregation is not fulfilling its purpose. In fact, there are many para-church ministries that seek to glorify God by performing one or all three of these other means in "bringing the lost to a saving knowledge of Jesus Christ, building them up in the Christian faith, and preparing them for Christian service." But in fulfilling these ministries they are not rivaling or replacing the church/congregations by conducting public corporate worship services. Public corporate worship is essential to the being and doing of a congregation. It is what defines and directs a congregation as a distinct visible corporate body within a community.

This was the first step in determining what the Session could and should do. We had to be true and consistent with our governing documents as to what was permissible and what was necessary. As we considered the Scriptures and our Standards, it became clear to us that suspending public corporate worship indefinitely without any reliable forecast during a pandemic was beyond the Session's authority. We concluded that public corporate worship was such an essential aspect of our congregation's public existence that we could not cease from calling the congregation to worship regardless of how many members gathered. Under the authority of God, His Word, the ARP Standards, and the knowledge we had about the coronavirus, we believed that we were being faithful to the Lord by maintaining corporate worship. In the coming months, we will see more specifically how the nature of corporate worship and gathering on the Lord's Day buttressed our decision all the more.

The means by which a congregation glorifies God are listed ("by conducting..., bringing..., building..., and preparing...") and joined by the conjunction "and" which implies that all these means are to be **included**.

Churches in Britain face new challenges and opportunities. At Christ Church Presbyterian, we meet online for worship and prayer on Sunday and midweek. We send out a weekly ministry letter in the post, are in regular contact with members, and are also using the time to make progress on the next phase of facility development.

When vulnerable people began to self-isolate, we distributed leaflets to 2,000 households, offering support and advertising our online ministry. We've made several new friends by shopping for groceries or picking up medications. New friends receive our weekly ministry letter. Many others are "friends from a distance," as they explore ministry online.
